This indenture made the 20th day of October in the year of our Lord one thousand seven hundred as Sighty nine Detween Henry Sawash late of the County of Berkeley and state of Virginia of the one part and Christopher Fulk of the said County and state of the other part witnesseth that for and in Consideration of the sum of five hundred pounds to the said Henry Sawash in hand paid by the said Christopher Fulk at or before the sealing and Delivery of these presents the Receipt whereof is hereby acknowledged Me the said denry Sawash hath granted Bargained sold Aliened and Confirmed and by these presents Doth grant bargain sall Alica and Confirm unto the said Christopher Fulk his Heirs and assigns forever a Certain tract or parcel of land lying and being in the aforesaid County and state being part of that tract of land Conveyed to Laurence Linder by Simon Linder and Pary his wife and by the said Lawrence Linder and Rebecca his wife Conveyed to Jacob Linder by Indenture Bearing date 18th and 19th of June AD 1730 and by the said Jacob Linder and Elizabeth his wife Conveyed to Henry Sawash by Indenture bearing date 17 and 18 day of Jovember 4D 1784 and is bounded as follows. Beginning at a History Standing at the head of a spring and running thence through the middle of the spring N 33 E thirty poles to a small heap of stones thence N 73 & Sixty poles to an old white oak and some marked white oak Saplins upon a stony Ridge then N 3 E twenty bix poles to four white cak saplings thence S 56 E sixty poles to a locust then N 82 E Ninety six poles to a white oak standing on the line of the intire tract thence with the same South 20 Et eighty seven poles to e white oak Corner thence 8 55 at ninety six poles to a Brook of water thence with the meanders of the same 173 poles to the Beginning Containing and also 11 houses Baildings orchards ways water water Courses profits Commodities Hereditaments & appurtenances whatspever to the said Premises belonging or in anywise appertaining and the Reversion and Reversions Remainder and Remainders Rents Issues and profits thereof and also the estate right title Interest use trust property Claim and demand whatsoever of him the said Henry Sawash of in and to the premises to have and to hold the tract of land above mentioned and all and Sundry its appurtenances unto the said Christopher Fulk is heirs or assigns forever to the only proper use and behoof of the said Christopher Fulk his Heirs or assigns forever and the said denry Sawash for himself and his heirs Exrs Adminrs doth Dovenant promise am grant to and with the said Christopher Fulk his heirs or assigns that the said Henry Sawash now at the time of the sealing and Delivering of these presents is Seized of a good Right in fee simple of and in the premises and that he hath full power lawful and Absolute Authority to grant and Convey the same to the said Christopher Bulk in manner and form aforesaid and that the Premises now are and so forever hereafter shall remain and be free and clear of and from all other gifts Bargains sales Dower fight and title of Dower Judgments Executions titles trouble charges am Incumbrances whatsoever made done Committed or suffered by the said Henry Sawash or his heirs and of all and every other person and persons whatsoever the annual rent to be hereafter due for the same to the Chief Lord or Lords of the Fee for the time being only Excepted and Lastly that the said Henry Sawash and his heirs the tract of and above mentioned and all and singular its appurtenances unto the said Christopher Fulk his heirs or assigns against the said Henry Sawash and his heirs and all and every other person and persons whatsoever shall and will warrant and ever delend by these presents In witness whereof the said Henry Sawash hath hereunto set his hand and seal the day and year first above written
